I am directed to convey the approval of the Government of India for payment of the following rates of Custom Milled Rice (CMR) in respect of paddy <u>procured under relaxed</u> <u>specifications</u>, as per specifications issued vide this Deptt.'s letterNo.8-10-2006-S&I dated 25.10.2006, under the price support operation to the Government of Orissa and its agencies during the KMS 2006-07 which will be effective up to date of issue of these orders only.

Note: The payment of incentive bonus will be subject to the condition that State Government fully exempts this bonus amount from all the State taxes and levies including VAT. State agencies also have to certify that the amount of the bonus has actually been paid to the farmers.

1. (i) Incidentals for the stocks of CMR, which are handed over to the Food Corporation of India for the Central Pool (item wise details of procurement incidentals are enclosed at Annexure-I):

(For transportation of rice from mills to storage point beyond 8 kms. the charges will be payable based on rate fixed by the District collectors of the State or Food Corporation of India's rate whichever is lower subject to a maximum of Rs.8.43 per qtl.)

(ii)Economic cost for the stocks of CMR retained by the State Government for distribution under the scheme of decentralized procurement operation (Item wise details of the economic cost are enclosed at Annexure-II)

2. In addition to the above, the following elements/items are also to be reimbursed to the State Government:

(i)Guarantee Fee, if it is actually paid by the agencies to the State Government for obtaining credit, would be payable on actual basis, subject to a maximum of 1/8% of MSP worked out on the estimated quantity of paddy delivered to Food Corporation of India

procured under Price Support Scheme(PSS) for the Central Pool. <u>No interest on delayed</u> payment on this account will be payable.

3. Milling charges have been allowed @ Rs.15 per qtl. for raw and Rs.25 per qtl. For parboiled rice including transportation charges within a distance of 8 kms from the mills on paddy as well as rice.

4. The Custom Milled Rice would be delivered by the procuring agencies to FCI, in new 50 kg bags only, in its local godowns up to the scale point and the stacking in the FCI godown will be done by FCI.

5. As per para 4 of this Department's letter No.192 (4)/2003-FC.A/Cs. Dated 16th July, 2003, the rate / cost of Custom Milled Rice (CMR) and other elements as indicated above are final. If the State Government feels that there is adequate justification for a revision in a particular component, the claim would be considered on the basis of detailed justification submitted for the increase, documentary proof and accounts audited by the auditors appointed by the Comptroller and Auditor General.

6. To ensure proper utilization of funds / subsidy being released by the Government of India, the FCI may insist on requisite certificates from the State Government and its agencies before release of incidentals on account of statutory charges i.e. Market Fee, RD Cess etc. as per past practice.

7. This issues with the approval of the Integrated Finance Division vide their Dy. No.1439/FA/2007 dated 16.5.2007.
